## Scholarship

### **What is an ICCA Scholarship ?**

ICCA will offer two scholarships a year to students who have completed the Wilton Course 1 program and who have the skills and the dreams to pursue further in the field of cake decorating but unable to do so due to financial obligations and reasons.

The Scholarship will cover the fees for the following Courses at ICCA for the successful applicants:

- Wilton Course 2
- Wilton Course 3
- Wilton Fondant & Gumpaste Course
- Wilton Method Instructors' Training Seminar

### **What are the criteria for applying to the ICCA Scholarship?**

To qualify for the scholarship, a student must have completed the Basic or Wilton Course 1 program.

### **Eligibility:**

A total household income in excess of RM3,000 per month is not eligible to apply for this Scholarship Program.

### **How does the ICCA Scholarship process work?**

Once a student has completed his/her Wilton Course 1, he/she will be eligible to apply for the ICCA Scholarship Program. The Scholarship Program is open to all Malaysians irrespective of race, age, gender and skill level. The scholarship application must be completed and sent to ICCA's Head Office at 1, Jalan PJU 5/15, Dataran Sunway, Kota Damansara, 47810 Petaling Jaya, Selangor to the attention of Ms. Vivian Tan during the application period. Once received, the applications will be reviewed and the shortlisted applicants will be called for an interview at a date and time to be determined by ICCA. Once the selection process is completed, two successful applicants will be notified in writing and will be asked to attend the Scholarship Presentation Ceremony at the end of each year.

### **What are the closing dates for the Scholarship applications?**

Scholarship applications will be accepted as of August 1 and the deadline and closing date for submission of applications is September 30 of each calendar year. Applications must be received at ICCA's Head Office at Kota Damansara before midnight of September 30 of each calendar year to qualify.
